#### MEDICAL SPECIALITY CODING IN STAFFLINK

#### **PURPOSE**

This Information Bulletin outlines the process to be followed to code medical practitioner positions in StaffLink.

Medical Speciality Coding supports the identification of medical positions and training pathways in the NSW Health System to facilitate workforce planning.

#### **KEY INFORMATION**

The Speciality coding is based on the Medical Board of Australia (MBA) list of medical specialities and fields of practice. All Medical Practitioner positions in StaffLink are to be coded.

Each position must be coded using the speciality code and speciality field and the position type. Each medical practitioner position in StaffLink must be coded following the process outlined in the Medical Specialty and Training positions schematic.

#### **Medical Speciality and Training positions schematic**

Positions will need to be coded when the position is established and updated if there is a change to the position, for example if an unaccredited junior medical officer position is subsequently accredited.

It is recognised that at times, there may be a requirement to place individuals against a position that does not reflect their training role. For example, a basic trainee may be placed against an advanced trainee position for 6 months because an advanced trainee has not been recruited or an unaccredited trainee may occupy an accredited position due to failure to recruit an accredited trainee. The coding of the position should not be changed in these circumstances if this is a temporary arrangement. However, if it is



determined to permanently fill the position with a basic trainee and convert the advanced training position to a basic training position or if the position changes to an unaccredited position permanently then the coding should be updated to reflect this change.

#### Assigning a speciality code

All junior and senior medical officer positions, with the exception of Intern and RMO1 positions, must have a speciality code assigned based on the speciality in which the position is located. The speciality codes and fields are listed in Attachment 1.

At a local level facilities may use different naming conventions to that of the MBA specialities as listed in Attachment 1 to identify a position. However, for coding purposes, the position needs to be linked to one of the MBA speciality codes. The identification of the speciality and field of speciality practice for accredited training positions will be guided by the accrediting college and needs to be consistent with the MBA speciality coding.

The speciality coding of accredited positions in a department provides a guide to the speciality code to be assigned to any unaccredited positions in the same department. Guidance in the coding of unaccredited positions may also be provided in considering the speciality classification of specialists appointed to positions in the Department.

#### Assigning a speciality code to Intern & RMO1 positions

All Intern and RMO1 (PGY1 & 2) positions should have the speciality code 510 (HETI accredited (Intern & RMO1) unstreamed) assigned as the speciality code.

# Assigning a speciality code to Basic Adult Internal Medicine and Paediatrics & Child Health Training positions

Basic trainees in adult medicine and paediatrics & child health undertake a variety of rotations during their training and their experience may be described as 'general'. However, positions and not individual medical practitioners are coded through this process. Therefore the basic training position should be coded according to the speciality in which the position is located. For example: A basic physician trainee position based in cardiology should have the speciality code 410 (Physician – Cardiology) and not 415 (Physician – General Medicine) assigned.

#### Assigning a speciality code to Rural Generalist training positions

Rural Generalist training positions provide training in advanced skills such as anaesthetics and obstetrics. Rural Generalist trainees are also enrolled in general practice training, however the speciality coding assigned to the Rural Generalist training position should be that of the advanced skills speciality and not general practice. For example if the position provides advanced skills training in anaesthetics then the speciality code to assign is 305 (Anaesthesia) and not 320 (General Practice).

#### Assigning a speciality code to GP VMO positions

General Practitioners, particularly in rural and regional health districts, may be appointed to hospitals to provide advanced skills services in a range of specialities such as anaesthesia and obstetrics. In coding the GP VMO position the speciality in which the GP is providing the advanced skill should be assigned to the position and not the general practice speciality code. For example if the GP VMO position is to provide



anaesthetic services in the hospital then the speciality code to assign is 305 (Anaesthesia) and not 320 (General Practice).

#### Education and Training specialty code

Positions established to support education and training of junior doctors, such as Director of Prevocational Education and Training and Network Director of Training, should be assigned the speciality code 331 (Education And Training). The Medical administration speciality code (330) **should not** be assigned to these positions.

#### Assigning a position type

All positions must have a position type code assigned. Position type definitions are at Attachment 2.

Junior Medical Officer Positions accredited for medical specialist training by an Australian Medical Council (AMC) accredited Medical College should be classified as either a basic, advanced or accredited position type (34, 35 or 36).

Intern and RMO1 positions accredited by the Health Education and Training Institute (HETI) for prevocational training should be classified as 33 HETI Accredited Intern & RMO1 Position.

Positions that are not accredited for training by a specialist college or HETI should be classified as 37 Hospital Non-Specialist Position – Unaccredited. Unaccredited positions include Career Medical Officer, Hospitalist, Resident and unaccredited trainee positions.

Some facilities or training programs may use different naming conventions to identify training positions. For example an accredited training position to be filled by a trainee at the later stages of their training may be designated as a Provisional Fellow position. However, as it is accredited for training it should be classified as either an Advanced Specialist Training position or an accredited training position.

As the position type and Speciality / Speciality Field are not dependent on each other, there can be multiple position types within each Speciality. For example, within the speciality of Emergency Medicine there may be Hospital Non-Specialist Positions – Unaccredited, Advanced Specialist Training Positions and Specialist positions.

Assigning position type to Adult Internal Medicine and Paediatrics and Child Health Training Positions

Adult Internal Medicine and Paediatric and Child Health Training positions should be classified as either basic or advanced training positions (34 Basic Specialist Training position or 35 Advanced Training position). The code 36 Accredited Training Position **should not** be used for these training positions.

Assigning position type to Surgical Education and Training (SET) positions

SET training positions should be coded as 36 Accredited Training Positions and **not** basic or advanced training positions.

#### **Coding examples**

Examples of coding medical officer positions using speciality field and position type:

1. An advanced specialist training position in Paediatric haematology will be coded as



Speciality Code + Speciality Field = 369 Paediatrics and child health - Paediatric haematology

Position Type = 35 Advanced Specialist Training Position

2. An unaccredited orthopaedic position will be coded as:

Speciality Code + Speciality Field = 478 Surgery - Orthopaedic Surgery

Position type = 37 Hospital Non-Specialist Position - Unaccredited

3. A Surgical Education and Training (SET) orthopaedic position will be coded as:

Speciality Code + Speciality Field = 478 Surgery - Orthopaedic Surgery.

Position type = 36 Accredited Training Position

4. A Staff Specialist Cardiology position will be coded as:

Speciality Code + Speciality Field=410 Physician - Cardiology

Position type= 39 Specialist/Visiting Medical Officer (excl GPs)

5. A Director of Clinical Training position will be coded as:

Speciality Code + Speciality Field=331 Education And Training

Position type= 39 Specialist/Visiting Medical Officer (excl GPs)

#### Relationship between Position Type and StaffLink classification

A Position Type can relate to more than one StaffLink classification. The business rules as set out in Attachment 3 limit this association to only the appropriate position type. For example, a position coded as a HETI Accredited Intern & RMO1 Position type cannot also have a StaffLink grade and classification of specialist.

The process to identify and assign the appropriate position type linked to a StaffLink classification is outlined:

- Step 1. Determine the StaffLink Classification of the position e.g. JMO Intern.
- Step 2. Using the StaffLink Classification as determined in step 1, select the corresponding relevant Position Type. (Definitions of each Position Type are at Attachment 2)
- Step 3. The Position Type code (e.g. 33 for HETI Accredited Intern & RMO1 Position) will utilise the existing DFF position field of **Primary Function in StaffLink**
- Step 4. If the Position Type has been identified as 33 HETI Accredited Intern & RMO1 Position in Step 3, then the Speciality Code and Speciality Field in StaffLink should be coded as 510 HETI Accredited (Intern & RMO1) unstreamed position. For other positions determine the appropriate field of speciality practice based on the speciality in which the Position Type undertakes the majority of its work e.g. 315 Emergency Medicine
- Step 5. The Speciality Code and Speciality Field (e.g. 315 for Emergency Medicine) will utilise the existing DFF position field of **Speciality Code in StaffLink**

Note: The Client Group in StaffLink should be 0 Not Applicable



# Relationship between Speciality Code/Field and ANZSCO (Australian and New Zealand Standard Classifications of Occupation)

As with speciality coding, each position in StaffLink must have an ANZSCO code assigned. The ANZSCO data is reported to NSW Department of Premier's and Cabinet.

The ANZSCO code of all position types, with the exception of 33 (HETI Accredited Intern & RMO1 Position), is determined by the speciality in which the position is located. The ANZSCO codes are shown in Attachment 1- Medical Specialty Code, Speciality Field and ANZSCO Code.

All intern and RMO1 positions will have an ANZSCO Code of 253112. However the ANZSCO code of other position types will be determined by the speciality in which they are located. One ANZSCO code will be linked to a number of different position types.

#### For example:

1. All of the following position types in Paediatric haematology will have an ANZSCO Code of 253321:

**Basic Specialist Training Position** 

Advanced specialist training position

Hospital Non-Specialist Positions - Unaccredited

Postgraduate Fellow Position

Specialist/Visiting Medical Officers (excluding GPs)

Clinical Academic

**Honorary Medical Officer** 

GP VMO position

2. All of the following position types in Orthopaedics will have an ANZSCO Code of 253514:

**Accredited Training Position** 

Hospital Non-Specialist Positions - Unaccredited

Postgraduate Fellow Position

Specialist/Visiting Medical Officers (excluding GPs)

Clinical Academic

Honorary Medical Officer

**GP VMO position** 

Assigning a speciality code to a position **will not** automatically assign an ANZSCO code and assigning an ANZSCO code to a position **will not** automatically assign a speciality code to that position.

#### **Maintenance**

After positions have been established, ongoing reviews need to occur to ensure that Position Type, Speciality Code + Speciality Field and ANZSCO code reflect the current status of that position.



Position coding should be updated at the time of any permanent change to a position, for example if an unaccredited junior medical officer position is accredited.

Otherwise a review of positions should occur when the position is advertised and/or through a regular annual process.

#### **ATTACHMENT 2 – DEFINITIONS**

#### HETI Accredited Intern & RMO1 positions

 Positions/Terms that have been accredited by Health Education Training Institute (HETI) for both Post Graduate Year 1 & 2 (PGY1/2) or JMO Intern/JMO Resident Medical officer training

#### Basic Specialist Training Position

- Positions accredited by the relevant specialty college/faculty/training organisation as being suitable for basic training.
- May include positions advertised as JMO Basic Trainee and JMO Senior Resident Medical Officer.

#### Advanced Specialist Training Position

- Positions accredited by the relevant specialty college/faculty/training organisation as being suitable for advanced training.
- May include positions advertised as JMO Advanced Trainee, JMO Provisional Fellow and JMO Trainee.

#### Accredited Training position

- Positions accredited by the relevant specialty college/faculty/training organisation as being suitable for training.
- Will apply where colleges do not separate training into Basic and Advanced Accredited training.
- May include positions advertised as JMO Advanced Trainee, JMO Provisional Fellow, JMO Trainee and JMO Senior Resident Medical Officer.

#### Hospital Non-Specialist Positions - Unaccredited

- Positions that are not accredited by a medical specialist college for specialist training.
- May include positions advertised as JMO Trainee, Career Medical Officer, Hospitalist.

#### Postgraduate Fellow Position

 A position filled by a medical practitioner who has completed postgraduate medical training and obtained their fellowship but who has not yet been appointed as a specialist/senior specialist.

#### Specialist/Visiting Medical Officers (excluding GPs)

 The position will be filled by a medical practitioner who has approved specialist qualifications from an Australian Medical Council (AMC) accredited specialist medical college (excluding General Practitioners). Includes those appointed as Staff Specialists, Visiting Medical Officers or Medical Superintendent.

#### Clinical Academic

 Position to be filled by a medical practitioner who is employed as a member of staff of a NSW university's school of medicine; and who accepts an offer of employment in the public hospital.

#### **Honorary Medical Officer**

 A position filled by a medical practitioner to provide a service or services or undertake training at certain facilities but who is not remunerated for those services.

#### **GP VMO position**

A position that is filled by a general practitioner.
