INCREASE IN CAR PARKING FEES

PURPOSE

This Information Bulletin has been generated to advise of a Consumer Price Index (CPI) increase in car parking fees. This increase commences, 1 February 2024 and relates to fees indicated in ([PD2013_031](#)), *Hospital Car Parking Fees Policy: Campuses which are subject to car parking development* and fees in ([PD2022_037](#)) *Car Parking – Concessional Fees and Eligibility*.

KEY INFORMATION

As per the provisions of ([PD2013_031](#)), the following rates shall apply from 1 February 2024:

Schedule 1: Public car parking fees for hospital campuses which are subject to car parking development

Duration	Base Rate (incl. GST)
First 15 minutes	Free
>1/4 hr – 1 hr	\$7.80
>1 hr – 2 hrs	\$11.60
>2 hrs – 3hrs	\$15.60
>3 hrs – 4 hrs	\$18.20
>4 hrs – 5 hrs	\$20.90
>5 hrs +	\$23.30
Maximum daily fee	\$23.30



Schedule 2: Concessional Rates

Duration	Fees (including GST)	Notes
0-3 hours	Free	
1 Exit only	\$6.50	Single visit tickets are valid for one entry and one exit only, per occasion.
3-day ticket	\$13.00	Frequent use tickets allow for multiple entries and exits to the Hospital Campus and are issued in 3-day and 7-day tickets.
7-day ticket	\$26.10	

Schedule 3: Staff car parking fees for hospital campuses which are subject to car parking development

Staff car parking fees in the financial year 2023-24 will be set at a standard level of \$27.20 per week (inclusive of GST).

Chief Executives are to ensure that the requirements of this information bulletin are communicated to all appropriate staff.

Directors of Financial Operations and General Manager of those campuses subject to car parking development are responsible for the operational compliance of this information Bulletin in accord with ([PD2013_031](#)), *Hospital Car Parking Fees Policy: Campuses which are subject to car parking development*.
