- Participate in forward planning and development of the hospital's clinical budget and identify and implement strategies and initiatives for the management of that budget, including ensuring that medical staff numbers remain within agreed FTE; efficient and effective medical workforce rostering and overtime management; and oversight of v-money, TESL and leave management.
- Encourage and foster a culture of research and teaching for both junior and senior medical staff.

- Have oversight and ownership of planning, coordination and reporting via the SLHD to Colleges and in consultation with the relevant training Directors, ensure that the governance and training aspects of the prevocational and vocational medical training networks are operating effectively.
- Ensure systems and processes for rostering, payroll and human resources management of medical staff a (including regular performance reviews) are followed.
- Participate in activities such as the on call roster, disaster management and SLHD or RPA committees as required, such as patient safety, medication, pathology committee meetings.
