Thank you for your email. As previously advised the report was originally redacted to protect the confidentiality and privacy of those that openly participated in the review. However, the College has on several occasions indicated its dissatisfaction with a redacted report. We therefore provided an unredacted report to be used for the limited purposes of the reconsideration process and on the proviso that it not be provided beyond the Committee and that it be destroyed following the Committee's consideration of the report.

Given the limited use of the report, we did not seek the consent of the staff involved in the report before releasing to the College. In accordance with the privacy principles under the Privacy and Personal Information Protection Act, we consider that those involved would have a reasonable expectation that their personal information would be disclosed as part of the College's interest in the cultural issues in the Department, which were the subject of the external review.
