You may recall Troy Trgetaric (Tresillian Director of Corporate Services) liaising with you about 2 years ago when you assisted in having our new Tresillian Lismore Centre added to the Schedule 3 list in the Health Services Act. Well, we now have another 5 to add since receiving NSW Health funding of \$2.2M per year in July 2018.
