Hi Olivia,

I understand and acknowledge that the Tresillian QEII Centre in the ACT requires separate insurance coverage. However, all Tresillian services in NSW funded by the NSW Ministry or LHD should be covered by iCare regardless of whether the schedule 3 list is updated or not.

By way of background, please see attached an email from Melanie Shea, from when she was at the Ministry and where she previously assisted Tresillian add on our new regional NSW Government funded services onto the schedule 3 list. At that time we submitted a proposal for these additions and added in the Contract we had with the Ministry of Health.

The Contract for the 6 newly funded Tresillian regional centres is still in progress and this is why we haven't submitted another brief to have these new centres added onto the schedule 3 list. I am currently liaising with April Deering from the Ministry on the Contract and I have included April in this email in the hope that she may be able to advise when it will be ready to sign off.

I also note in the attached NSW Health Act – schedule 3 list, that some AHO's like STARTTS are listed but have no location listed. I can advise that STARTTS operate physical site location services from Carramar (head office), Auburn, Coffs Harbour etc. I can also advise that Karitane is operating physical site location services from Oran Park, Balmain Shellharbour which are not on the schedule 3 list and that they no longer operate from Liverpool, even though it is listed. Would it be easier for Tresillian to be listed like STARTTS and not list any physical locations on the schedule 3 list?

Based on your advice, I need to raise this matter with the NSW Health Services
Association, so that all AHOs are made aware that their services may not be insured.
Can we please arrange a meeting to discuss this in more detail.

Can you please confirm that iCare will not insure the Tresillian regional centres

that have been funded by the NSW Government announced in June 2021 by the NSW Premier, The Hon. Bronnie Taylor MLC and the The Hon. Andrew Constance?

- · Can you please confirm that iCare, the NSW Government Insurer, will not fund the new NSW Government funded Tresillian services and that we are required to engage a separate insurance company?
- Can you please advise if iCare is ceasing our insurance cover effective immediately or does Tresillian remain covered until we get additional external insurance.

I will be contacting the relevant Ministers today to make them aware that Tresillian is now required to secure external insurance policies for the new services that they have funded us to provide.

I look forward to receiving a response and discussing this matter further.

Just following on from the email of Olivia below I wanted to confirm:

We note the Health Services Act, particularly the portions relating to the Affiliated Health Organisations which are those listed under Schedule 3 of the Health Services Act 1997.

The relevant portion being that an Affiliated Health Organisation means "a hospital or health institution of the organisation that is listed in column 2 of Schedule 3 next to its name. It also defines a recognised service of an affiliated health organisation to mean a health service or health support service of the organisation that is listed in column 2 of Schedule 3 next to its name." As the new entities acquired by Tresillian and located in ACT, Wagga Wagga and Macksville are not listed and as such cannot be included in the TMF cover due to wording of the Act.

This means the TMF is only able to cover those named & listed entities and to rectify the situation it appears that Tresillian need to progress through the process of having *additional* services included in column 2 through PARVAN/HSP.

I'll leave this with you to proceed as necessary

Hi Jeff,

Our Legal Branch advised the following:

- An AHO is only recognised in respect of their services or institutions listed in Column 2. The <u>Act</u> is quite clear. It was noted that there are a considerable number of entities listed in column 1 that have a wider portfolio of health services, but they only fall into the Act if the services in question are listed in column 2.
- If Tresillian wishes to have additional services included in column 2, they would need to make a case for it, this would need to be assessed through PARVAN/HSP.
- Finally the remit of the Health Services Act is within NSW and funding allocated under the Health Services Act comes from appropriations made by NSW Parliament for the community of NSW. As such, the Act cannot be used to recognise or fund services offered in other states or territories.
