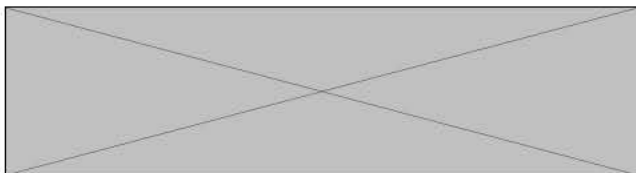

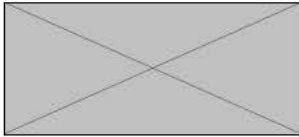

Hi Annette,

I hope you're well.

I was just touching base to see if there were any updates following our discussions with Anna Read (legal branch) and April Deering (Health and Social Policy Branch) on Monday 22 August?

I am hoping that our solution of listing Tresillian in column 2 as “Tresillian NSW services funded by NSW Health” has been considered.

The Tresillian Residential Beds in Macksville Hospital were to also be considered as an immediate inclusion into column 2 due to the complexities around inpatients being admitted to a public hospital by a body not listed in column 2. I also note that Karitane is currently in the same situation as Tresillian, with their Residential Beds at Camden Hospital not listed in column 2 and now we have a commitment from WNSWLHD to put 2 Tresillian Residential Beds into the new Cowra Hospital.

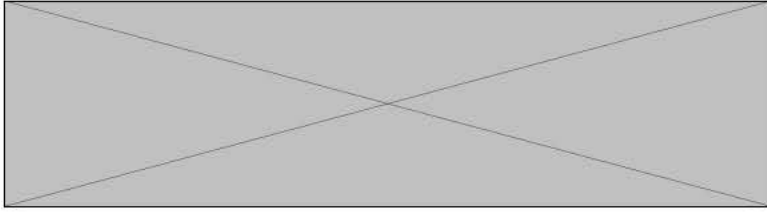
