Dear Leonie

At our last HSA meeting iCare-Insurance was discussed, notes from the meeting below:

"Mr Mills said Tresillian is still not covered for the 6 new regional centres. A matter under discussion includes the assumption that if a service/centre is listed in column 2, it can't be removed. However, Mr Mills advised that even if the service is listed in Column 2 and the service no longer exists, it is no longer a financial liability as the funding stops when the service stops.

Ms Lamont asked the HSA to put together a paper stating what that would look like".

Both Mr Mills and myself liaised with Tresillian's Legal Counsel on this amendment and Dr Smyth provided the attached proposed amendment to column 2 for Tresillian. This new amendment will ensure that all Tresillian services funded by NSW Health, now and also into the future, will be covered.
