St Vincent's Health Network 2024-25 Service Agreement

Analysis	On 19 February 2024, St Vincent's Health Network (SVHN) requested \$60 million in financial support from the Ministry of Health (the Ministry). The Ministry provided a one-off additional subsidy of \$30 million, with a corresponding amount to be - recouped by the Ministry across 2024-25 from the 2024-25 Service Agreement (TAB A).
	SVHN has raised concerns regarding the parameters of the current Service Agreement with the Ministry. SVHN would like to commence discussions to address a different approach to the partnership with the Ministry.
	The process of negotiating the 2024-25 Service Agreement with SVHN has commenced, with the Purchasing Roadshow held on 19 March 2024. The next meeting to discuss purchasing with SVHN is on 9 May 2024. It is proposed that the meeting be extended to facilitate the discussion sought by SVHN.

Key issues

SVHN seeks to enter formal discussions on the funding model in their Service Agreement

SVHN advises it will not be able to execute the 2024-25 Service Agreement under current funding parameters and without a shared position of the role of SVHN within the NSW Health system.

Concerns include capital funding, operating sustainability of SVHN, the strategic sustainability of the St Vincent's Sydney Health Innovation Precinct. SVHN is also concerned about the impact of the Ministry recouping the \$30 million subsidy across 2024-25.

SVHN cites unprecedented financial constraints across the State healthcare system, impacting both public and private operators.

The purchasing discussion is the appropriate forum to discuss SVHN's concerns

The 2024-25 Service Agreement and purchasing process is underway, with the next meeting with SVHN on 9 May 2024. The financial position and desire to discuss the structure of their Service Agreement was raised at their Purchasing Roadshow on 19 March 2024.

It is appropriate that the meeting on 9 May be extended to facilitate the discussion SVHN is seeking. System Purchasing Branch will engage with SVHN in the lead up to the meeting to ensure that the agenda and topics for discussion are known and promote a productive discussion.

Context

St Vincent's Health Network is part of NSW Health and part of SVHA Group

SVHN is part of St Vincent's Health Australia (SVHA), a not-for-profit organisation that provides care to the poor and vulnerable comprising operating divisions of Private Hospitals, Aged Care, Public NSW (SVHN) and Public Victoria (St Vincent's Hospital Melbourne).

SVHN is an Affiliated Health Organisation under Schedule 3 of the *Health Services Act* 1997 and is one of the health system's designated Networks.

SVHN's 2023-24 Service Agreement Initial Budget Allocation is \$450.988 million. This increased by 1.1% from 2022-23 noting funding and activity was transferred out of St Vincent's to Western Sydney Local Health District for the transition of St Joseph's Hospital services which impacts this comparison (notional comparison in Service Agreement indicates 3.8%).
