Dear Mr Mullane

Thank you for the opportunity to comment on the Terms of Reference for the Special Commission of Inquiry into Healthcare Funding.

There are ongoing, large-scale disparities in health outcomes and inequities in service access between people living in our cities and those in regional and remote regions. The situation is exacerbated by chronic rural health workforce shortages, and the unequal impacts on rural populations of the social and environmental determinants of health, which have become a global challenge.

Both Federal and State governments have attempted to address the health workforce inequities with substantial funding channelled into rural health (largely medical) workforce training schemes, infrastructure and, in NSW, a hub and spoke model of service.

The University of Sydney has historically made a strong commitment to improving health outcomes and health workforce training in rural NSW, including by establishing and operating two of the first Federally funded University Departments of Rural Health (UDRH), in Broken Hill in 1996 and in Lismore in 2001, and one of the first Rural Clinical Schools (RCS) in Dubbo in 2001. The separate Australian Government programs supporting UDRHs, RCSs and rural dentistry training were brought together in 2016 through the Rural Health Multidisciplinary Training (RHMT) program which now also includes Regional Training Hubs focused on rural junior doctor training.

In considering the Terms of Reference for the Inquiry with a rural health lens and drawing on our expertise in this field, we recommend:
